If the facility has to be cleaned by the rangers, a fee of \$20.00 per hour will be charged and deducted from the deposit fee.
- * You are responsible for cleaning the facility and having it in the order in which you found it. Floors must be swept and clean, stoves must be cleaned; items used in the kitchen area must be washed and put back into place. tables must be wiped off. All areas around the lodge, beach area, and deck off the lodge must be cleaned of any debris.
- * Lodge Rental ends at 10:00 P.M., There shall be no Lodge Rental on Board meeting days or when activities have been scheduled for the membership.
- * Members are allowed access to Restrooms and Recreational area in Lodge.
- * Any additional trash cans, liners, wood, must be arranged with the rangers prior to the date of the event.
- * Tables and chairs for the event, must be stacked and put back into their original location.
- * Along with this form, you must attach a Guests Registration Form for each guest that will be attending the event. You will be responsible for these guests to enter the park and to follow all By-Laws, Rules, and Regulations of Lake Trask Timber Trails Association.
- * Lake Trask Timber Trails Association is not responsible for lost or stolen items during your event.
- * CANCELLATION FEE: All cancellations must be made within 5 days of the event otherwise there will be a \$50.00 cancellation fee.
