GUEST GATE CARDS WILL BECOME DEACTIVATED THE FINAL DAY OF THE WEEKEND STAY. THE \$20.00 DEPOSIT WILL BE RETURNED IN FULL TO THE MEMBER ON RETURN OF GATE CARD TO THE OFFICE IN PERSON, OR WILL BE CREDITED TO THE MEMBERS ACCOUNT WITHIN 5 DAYS IF RETURNED TO THE OFFICE DROP SLOT AFTER HOURS.
